VOI and KYC via video technology

VOI and KYC via video technology, such as Skype or FaceTime, may be used if you cannot meet the customer(s) in person.

First you must get the applicant(s) to send a copy of their identification documents to the broker conducting the VOI. The applicant must display the original ID via video, and you must be satisfied the copies match the originals. You will also need to provide a comment as to why you utilised video as the verification method in AOL.
